

- (1) To join TLFA you must serve a probationary period of three (3) months and pay a three (3) month pro rata fee of the annual membership fee.
- (2) At the completion of such period and subject to approval by the executive committee you shall be eligible for full membership.
- (3) During the probationary period you shall be entitled to participate fully in the club activities and speak during debate at club meetings but shall not exercise a vote or put motions in club decisions. You are not eligible to hold executive office.
- (4) All persons 18 years and over are required to read and sign the Child Safe Code of Conduct.
